During this period, I was instrumental in setting up the TKC A/C restaurant within the allotted budget. Introduced Delightz cafe and the CCC coffee shop.

During my second tenure (2023–Oct 2024), I introduced the Karavalli seafood vendor, bringing greater variety and quality to the club's dining options. Played a pivotal role in bringing Sherlock's

to our club, which not only offers members a premium dining experience at reasonable prices but has also significantly increased club revenue. Supervised and ensured excellent catering arrangements for the Club day and all club events held during my tenure. Instrumental in setting up the AC restaurant within a limited budget during my first tenure. Introduced brunch on Sunday at Sherlock's and a Wednesday buffet @ ₹299 in the TKC A/C Restaurant.

As Chairman – Library, IT & Children's Park (Oct 2024 to present), I have ensured the availability of the latest editions of leading magazines and books, procured nearly 50 new books and novels based on member suggestions, and successfully inaugurated a new library with a dedicated Wi-Fi connection during my tenure.

To enable single billing and upgrade our club software, I have already obtained an estimate from the vendor, which was also approved in the MC meeting, and implementation will take place after the elections.
